
STATE OF THE FEDERATION REPORT

NFCYM Highlights and Initiatives

Affiliation

In 2009, one hundred and seventy nine dioceses—96 percent of all Catholic dioceses of the United States—affiliated with the NFCYM, and fifty-nine national youth-serving organizations affiliated as collaborating members.

NFCYM Leadership

Chair of the board, Carole Goodwin (Louisville); first vice chair, Paul Mach (Joliet); second vice chair, Michal Horace (Portland, Oregon); secretary/treasurer, Michelle Maher (Colorado Springs); episcopal advisor, Bishop Jaime Soto (Diocese of Sacramento).

National Staff

We continue to adapt our new structure for accomplishing our work as a national staff. Staff is aligned in four work groups based on critical areas: membership services, operations, meetings and events, and communications and publishing. This structure fosters intentional collaboration and a better utilization of staff's gifts and skills. (See diagram on page 24.)

In addition we are honored and blessed to be the host of students from the Don Bosco Cristo Rey High School in the Archdiocese of Washington. We began the school year in August 2009 with two students who each visit us once a week. We currently host one. This experience has given staff the opportunity to mentor students and provide them with experience working in the "real world" in addition to their studies. We look forward to continuing this partnership with the high school next year.

Board of Directors

There is a separate letter from the chairperson of the board, but it is worth noting that the board engaged in several discussions around the topic "Is NFCYM structured for success?" The conversation looks at our definitions of 'success,' our strategic planning process, our current organizational structures, and influences from the wider church and culture. This conversation goes to the membership at the 2010 Membership Meeting.

Catholic Youth Foundation USA

There is a separate annual report from the CYFUSA, but it is worth noting that CYFUSA conducted several significant fundraising campaigns this year: the Everest Campaign was our first totally electronic campaign through e-mail and the website; the "Put Five Aside" campaign at 2009 NCYC raised over \$127,000 from the participants, spurred by an anonymous matching donation of \$100,000; and the fall Bishops Campaign was also well supported. CYFUSA provided over \$100,000 in conference scholarships and in youth ministry grants in 2009.

Alliance for the Certification of Lay Ecclesial Ministers

NFCYM, NALM, NCCL, NPM, and FDLC partner in the Alliance for the Certification of Lay Ecclesial Ministers and are developing a shared, national process for certification and revising the current standards. We are also fostering inter-organizational collaboration on certification and accreditation issues. The draft process and the draft standards are currently distributed to all organizational memberships for feedback. The final drafts will come to NFCYM membership in January 2011.

National Initiative on Adolescent Catechesis

The NFCYM is an active member in the Partnership for Adolescent Catechesis (PAC), a collaborative effort including the NCCL and NCEA, with the support of USCCB. PAC is implementing a six-year national initiative designed to explore the concerns surrounding adolescent catechesis and identify critical issues, approaches, and practices. Two Sourcebooks on Adolescent Catechesis were published, a website developed (www. adolescentcatechesis.org) and a Vision, Outcomes and Indicators for Adolescent Catechesis have been advanced. In 2008 PAC received a \$450,000 grant from the Lilly Foundation and \$75,000 from an anonymous foundation to support the 2008 national symposium on adolescent catechesis and to continue training and research efforts beyond the symposium. Ela Milewska is the project coordinator.

NFCYM Training In-Services

Launched in May 2006, in-services are conducted in dioceses across the country annually. This past year sessions on Multi-Parish Ministry and Youth Ministry in Multicultural Communities were created by the task group, as well as a process to recruit additional trainers. Our new project, Strong Catholic Families: Strong Catholic Youth, will be unveiled in January 2010. This project includes a training component for parish and diocesan leaders, diocesan trainers, and a parent session. NFCYM received an ACTA grant for \$10,000 to support Catholic families and print materials for the project.

National Catholic Youth Conference (November 19-21, 2009, Kansas City)

Over twenty three thousand participants, speakers, exhibitors, and volunteers attended the NCYC in Kansas City, Missouri. The conference was enhanced by the use of technology: from Facebook and Twitter, to the split general sessions, and by the live streaming of the conference. Over 32,000 distinct visitors from 106 countries visited the NCYC via the Internet. Further, we introduced a parent track of workshops which were very well attended. A conference highlight was the Eucharistic Procession through the streets of Kansas City. Our

gratitude goes to the host (Arch)Dioceses of Kansas City and Kansas City-St. Joseph for the wonderful hospitality and support provided by their twelve hundred volunteers.

New Diocesan Directors Institute (May 27-30, 2009, Washington, D.C.)

This program, entering its fifthteenth year, trained twenty-two new diocesan directors of youth ministry, including two from Canada, in their role, identifying available resources, and developing peer support groups. NDDI is a collaborative partnership with Saint Mary's Press and the CYFUSA.

Communications, Publishing, and Marketing

Under the area of Communications and Publishing the organizational tasks of electronic and print communications, marketing, and publishing are carried out in relationship to the Communications and Publishing Management Committee. Highlights of the past year include:

- Launching the new series Living and Loving Our Catholic Faith that replaces the Youth Ministry Resource Manual. Two editions with prayer cards were published in 2009: Sunday and Beyond that unpacks worship and liturgy, and Saints—Yesterday, Today, and Tomorrow.
- Annual Bishops Report was distributed to the U.S. Catholic Bishops in October.
- Creation of the new Family web resource area (http://www.nfcym.org/family/index.htm) on the public website in October.
- Continuing a focus on supporting Catholic parents, NFCYM published Raising Happy, Healthy, and Holy, Teenagers: A Primer for Parents by Bob McCarty.
- Major revision of the NFCYM Publications Guide by subject matter. This has created corresponding changes to the NFCYM Online Store.
- A focus on the environment with NFCYMS's new web resource area (http://climate.nfcym.org) launched in May and Tread Lightly; Lift Up the Lowly key chains developed in November.
- Development and distribution of the Source Book on Adolescent Catechesis, Volume 2 (July).
- Prayer cards for the Family of God, I Live My Faith, Mary, the First Disciple, The Spirit Alive, St. Elizabeth Ann Seton, and St. Anne religious recognition programs were printed to support these programs and may be used to supplement Saints—Yesterday, Today, and Tomorrow.
- Two additional logo products were developed for the NCCGSCF: oxford shirts and stickers.

Service Centers

NCYOS and NACYML continue to expand their services and membership base. Their reports are included in this State of the Federation Report.

Networks and Liaisons

The NFCYM is involved in several critical collaborative projects.

- NFCYM was a partner with La Red on the national process for Encuentro 2006 and for the gathering at Notre Dame University in June 2006 and collaborated on a follow up strategic plan for implementing the Encuentro conclusions. This strategic plan was approved by the NFCYM board in January 2009 and NFCYM is working with La Red in its implementation.
- Washington Theological Union has a Lilly grant to ascertain and develop vocation and ministry career paths and the NFCYM is a partner in this project. In June 2007 thirteen dioceses sent teams to WTU for an institute designed to create intentional pathways to pastoral leadership and in June 2008, eleven dioceses participated in a follow up institute. A resource for parishes, schools, colleges and dioceses will be available in early 2010.
- NFCYM serves as an advisor to the USCCB Committee on the Laity and to the USCCB Committee on Catechesis and Evangelization.
- NFCYM has an agreement with NCYAMA whereby NFCYM serves as the management company for NCYAMA. The agreement includes, accounting/ bookkeeping, clerical support, meeting planning, website development, communications, and administration.
- NFCYM will be a cosponsor of the 2011 National Symposium on Lay Ecclesial Ministry at St. John's University in Collegeville, Minnesota.
- NFCYM participated in the 2009 National Leadership Roundtable on Church Management Conference, focusing on best practices in the use of technology in ministry.

Strategic Plan

The Strategic Plan was approved at the 2006 membership meeting and implementation began at the 2007 membership meeting with identification of lead agents and an examination of management committee mandates. Progress on implementing the objectives is monitored by the first vice chair and a report is being presented at the 2010 membership meeting.

NFCYM Board of Directors Report

At the spring meeting, the board unanimously voted to renew Bob McCarty's contract as executive director for the next two years. NFCYM Management Committees

Adult Training and Certification Management Committee

Key Issues and Challenges

A key issue continues to be adapting our work in all task groups to Co-Workers in the Vineyard of the Lord and the strategic plan. The Certification Standards are being translated from five common standards to four. Increased participation from a diversity of ministries, ethnicities, and national agencies provides for a more complex process, but yields more relevant training services, standards, and formation processes. Development of two new task groups this past year, Diocesan Directors Job Description and Pathways to Ministry, also reflects the new focus brought to our committee from Co-Workers. The economic realities in which we live, the resulting cutbacks in diocesan and parish ministries, the accumulation of responsibilities by fewer people and the limited resources, bring great challenges to our ability to meet and the time we have to dedicate to particular areas of responsibilities.

Adult Spirituality

Judy Alvarez continues as chair of this task group. The task group has helped animate Prayer and Spirituality venues for the past four NCCYM conferences. Recently we determined that program elements that are now standard to NCCYM programming ought to be animated through the NCCYM Leadership Team. The Adult Spirituality Task Group continues to plan and implement Café Soul for the conference and is now focusing new energies on developing an NFCYM webpage for spiritual development resources.

NCCYM

Kristin Witte continues as chair of this task group through the December 2010 conference. The results of the Leadership Team's hard work to create infrastructure has begun to pay off as the task group's subcommittees continue to generate amazing and efficient results! Examples include: March with the Saints theme and logo were completed and approved two years in advance, featured speakers and emcees were discerned 18 months in advance, and the NCCYM workshop submissions committee sifted through nearly 300 submissions and have selected about 60 to be presented (invitations will go out after the 2010 membership meeting). The Diocese of New Orleans is being extraordinarily generous in their support of the CYFUSA by donating proceeds from the local event "Taste of New Orleans" which will feature Mardi Gras floats, jazz and values bands, and a sampling from the best restaurants in the area.

New Diocesan Directors Institute

Michelle Maher continues as chair of this task group. The 2009 New Diocesan Directors Institute (NDDI) was held in Washington, D.C. May 27-May 30 at the Washington Theological Union. We had 22 participants including two participants from Canada. Much conversation reflected around the fact that new leaders are coming in with more knowledge and experience and the institute needs to be adjusted in light of this. NDDI has experienced an increase in Hispanic ministry leaders over the last several years, which is an excellent sign for the future.

Sustaining the Spirit

Steve Polley is the new chair of this task group. The first *Sustaining the Spirit* event, conducted as a preconference to the 2008 NCCYM was a great success. Based on a review of past evaluations the task group has secured space for the next Sustaining the Spirit Retreat at Cenacle Retreat House in Metairie, December 7-9, as a preconference to the 2010 NCCYM. The participants will be transported to the conference hotels from the retreat center at the conclusion of the program.

NFCYM Training Services

Colette Kennett is stepping down as the chair of this task group; her replacement will be discerned at the Membership Meeting. This task group continues to survey the membership assessing new needs for training inservices while maintaining those in-services that remain vital to ministry growth. In-Services presently in place: NSYR, Renewing the Vision, Tools for the Vineyard, Multi Parish Youth Ministry, Multicultural Youth Ministry. The newest program is the Strong Catholic Families, Strong Catholic Youth which debuts this month. Future focus will be on technology and ministry.

Accreditation and Certification

Kathy Goller continues as chair of this task group/ commission. Members of the Commission represent NFCYM on the National Alliance Committee. Roberto Navarro. Archdiocese of Galveston-Houston and a member of La Red, is a new member of the Commission. The Commission has drafted revised Specialized Competencies for Youth Ministry Leaders which are included with the full draft of the revised standards and competencies. These drafts and the certification process will be available to all NFCYM members for consultation and feedback during the 2010 Annual Membership Meeting. Members can also give feedback via a survey (link will appear on the iNet). Accreditation and Certification will collate all responses and compile the NFCYM response to the documents. NACYML is in the process of developing volunteer competencies.

Kathy Goller and Bob McCarty represent NFCYM on the Alliance for the Certification of Lay Ecclesial Ministers (governing body) which is working on the revision of the National Certification Standards and the development of a national certification process. The Alliance is also developing a Memorandum of Understanding to guide the various national organizations who comprise it. They are also seeking to compile one Code of Ethics that can be used by lay ecclesial ministers. Rita Ramos from Omaha will represent NFCYM on this Alliance task group.

Diocesan Leaders Job Description

Mark Mann from Grand Rapids is chairing this task group as it creates a diverse tool for developing a job description for a diocesan director of youth ministry. They have worked in collaboration with Accreditation and Certification Commission, the national office, and various materials used with NDDI. The template is being developed with five sections: Administrative, Coordination and Collaboration, Advocacy and Consultation, Supervision and Leadership, and Minister. They anticipate completion of their work on the job description prior to the 2010 Membership Meeting.

Pathways to Ministry

This new task group chaired by Grace Cassetta (Las Cruces) was approved at the fall board meeting and consists of four members. Their goal, which flows from our updated mandate, is to address the barriers that prevent people from hearing and answering the call to the vocation of a lay ecclesial youth ministry leader. As a result a wider diversity of people will be able to rise up into ministry positions prepared to serve and answer their call.

Advocacy Management Committee Submitted by Brian K. Johnson

This past year the Advocacy Management Committee reviewed its mandate and found the current description to be lacking in focus in the true ministry of advocating for the needs of youth and youth ministry. In lieu of this, we have submitted a draft mandate to be presented to the membership in January 2010. It is our hope that this will be voted upon early in the meeting so that the management committee is able to be fully functional in its scope. Works in Progress

- Living and Loving Our Catholic Faith, Church: Being, Becoming, Believing—"Being Church" will focus on the church as People of God, the Kingdom of God and the mission of the church. "Becoming Church" focuses on initiation, ongoing conversion, and being a lifelong learner. "Believing Church" focuses on how our "being" is manifested concretely (solidarity and diversity). Our goal is to have it ready for purchase at NCCYM.
- Continuous Website Updates—This task group has fizzled and needs to be reconstituted at the membership meeting. Currently, the majority of input comes from the management committee. Some discussion of who the primary audience is has been addressed, as well as possible secondary and tertiary audiences. Discussion will continue at Membership Meeting.
- Connections and Connected Publications—Further discussion at the Membership Meeting will take place as to improvements needed to Connections as well as possible name changes to one or the other to eliminate confusion. An invitation will be made at Membership Meeting to seek potential authors for Connections who do not have to serve on the task group or management committee.
- I Live My Faith—The task group's chairperson, Shannon Perzan (Region 1), has coordinated the review of this document and submitted a reort for this membership meeting.
- From Age to Age Revision—Kathy Carver has been working with FDLC on an organizational agreement and three-year budget projection.
- Strong Catholic Families, Strong Catholic Youth—This
 publication resource will accompany the in-service.
 The CPMC reviewed the initial draft via conference
 call. A second draft is ready for review at the
 Membership Meeting with publication immediately to
 follow.
- Climate Change Projects—Mark Moitoza is working on materials for a Phase 1 roll out. Deadlines and additional project development will be addressed at the Membership Meeting.

Potential Projects

- Parent/Family Resources—Amy Tadlock (NFCYM staff)
 has been working on information for the website.
 What does it mean to be Domestic Church? How do we
 better connect with teenagers? Currently, information
 is provided on on growth, development, culture, and
 faith. We will address if there is a need to collaborate
 with the Strong Catholic Families document to provide
 additional web materials.
- Social Networking Resource—There is a growing need to provide a resource on the best practices of using social networking sites in youth ministry. A potential partnership with USCCB's Safe Environment office may be needed as they do not plan on drafting their own document. An additional task group may be needed.

Finance and Marketing Management Committee Submitted by Milissa Thibodeaux

The Finance and Marketing Management Committee (FMMC) monitors the fiscal health of the organization. It carefully reviews proposed and actual budgets and responds to areas of concern. Our Federation is largely driven by conference and publications revenues that principally determine the stability of the operating budget. It also means that the budget runs on a two-year cycle which can make planning more challenging.

The 2008-2009 fiscal year included 2008 NCCYM (Cleveland). Paid attendance was 1,652—about 350 less participants than anticipated—resulting in a lower than budgeted income. However, the overall NFCYM budget ended with \$270,000 less deficit for the entire fiscal year, which is a positive accomplishment because of our two-year budget cycle. We anticipate the two-year cycle, 2008-2010, to show a profit, considering the increased attendance at 2009 NCYC. Therefore, the Federation financial reserves have finally been replenished.

Because of the economic downturn and the uncertainty in the economy, the FMMC developed a budget based conservatively on attendance at 2009 NCYC at 17,000 paid registrations. FMMC also developed two additional options should attendance exceed the target. 2009 NCYC had 19,800 paid attendees, with approximately 1,000 complimentary registrations. The increased numbers

required an overage of \$250,000 in expenses and a final financial report will be available this spring. However, we are very positive about the financial implications and supported complimentary registrations at this membership meeting for a representative from each diocese and collaborating member.

Based on the FMMC recommendation in January 2009, the NFCYM has created an Unrestricted Operating Reserve of \$600,000 in our Institutional Investors Income Fund. This reserve fund has been set aside to cover expenses in case of a significant economic crisis at NFCYM.

NFCYM members should note the critical impact that the number of attendees at youth and adult conferences and our publication sales has on the Federation budget. It has implications for all the work of the NFCYM. To this end, the FMMC has developed two-year budget projections for the next six years to strengthen our long term planning.

The FMMC also monitors our investment policies and strategies. This has become a particular challenge in our long-term investments (mutual funds through Pax World), while our short-term investments have done well (5.65% annual growth).

The FMMC authorized a Marketing Task Group that developed a marketing plan for NFCYM services, conferences, and products. The national staff is charged with primary responsibility for implementing the marketing plan. FMMC also designated \$41,600 for marketing and exhibiting for the 2009-2010 fiscal year.

The FMMC established a task group to review national staff salary scales and has conducted research into salary ranges for nonprofits and ministry organizations both in D.C. and nationally. Proposed salary scales will be discussed at the FMMC meeting in preparation for the development of the FY'11 budget.

The FMMC is chaired by Milissa Thibodeaux diocesan director in Lake Charles. This past year was a time of transition and rebuilding of a new committee with several members rotating off the committee in the previous year. Our main focus has been to develop a proposal for a needs assessment/strategic planning process. A proposal was presented to the board and a decision was made to create a joint board/MMC task group that would implement the strategic planning effort.

A proposal for the diocesan director survey was presented and approved by the board, and will be executed by Ministry Training Source in 2010.

The MMC oversaw the new collaborating member application process and concurs with the assessment by the task group, that a year to restructure and redevelop the process is needed, due to a variety of questions and clarification issues that came up with the existing slate of applicants. The NCCGSCF oversees the religious recognition programs and training opportunities for diocesan and parish leadership and for Catholic leaders in Girl Scouting, Camp Fire, and other Catholic youth groups. We also help to develop national policies and guidelines to assist regions and dioceses in implementation of religious emblem programs and any other programs developed by the NCCGSCF.

At the 2009 Membership Meeting we evaluated the success of the Alive in the Spirit Symposium that was presented at the 2008 NCCYM in Cleveland and continued the discussion throughout the year. Although we had a positive experience and those who attended found the workshops

valuable, the committee has decided for several reasons to return to the original format with an NCCGSCF track. Preparations are already underway for the NCCYM in New Orleans.

Our committee has been given the permission to develop new patches centered around different themes. Our first project was an NCYC patch showing the NCYC logo. The project was a huge success and the patches were sold out. Plans are now underway for the next patch which we hope to have available for our gathering in New Orleans.

Regional representation continues to be a struggle for us although we have added new representatives in Region 6 and Region 12. We encourage those regions who do not have representation on our committee to continue the search and discernment process.

New efforts are being developed and enhanced to assist leaders in the following areas: Youth Ministry and Technology, resources for Multi-Parish Youth Ministry Clusters, and networking for Young Adolescent Ministry.

Youth Events Management Committee Submitted by Bob Perron

The Youth Events Management Committee (YEMC) successfully completed the implementation of the 2009 National Catholic Youth Conference (NCYC) cohosted by the Diocese of Kansas City-St. Joseph and the Archdiocese of Kansas City. We are particularly grateful for the work of Maureen Gross of NFCYM, Jon Schaffhausen of the Diocese of Kansas City-St. Joseph, Dana Nearmyer and Kimberly Rode of the Archdiocese of Kansas City, and Declan Weir of Declan Weir Productions. NFCYM served more than 20,875 participants from 163 groups, 750 exhibitor personnel representing 203 exhibitors/organizations, and 28 bishops from across the country. With the addition of local volunteers, speakers, and performers we were about twenty-three thousand strong. Highlights from the conference included keynote presentations by Bob McCarty, Cardinal DiNardo and Brian Johnson, and Jason and Crystalina Evert. Our final general session featured keynote testimony from five young people; Phillip Ryan, Stephanie Mueller, Felix Montalvo, Chidera Ufondu, and Sami Freese all did a wonderful job. Another program highlight was the very moving experience of Eucharistic adoration and procession from Sprint Center to the Kansas City Convention Center, the likes of which neither Kansas City nor NCYC had ever seen. We were blessed with great weather, patient and reverent participants, and strong advocates and supporters within the Kansas City community which made the whole thing work so well.

The Enlace Task Group (formerly Encuentro Follow-Up Task Group) has been one of our most active task groups this year. At their last conference call they identified some positive ways cultural integration was seen at NCYC and also pointed out some of the challenges as we continue to move forward. They are currently discussing "next steps" and are working on value statements and structure.

This year the Bishop's Involvement Task Group wanted to involve the bishops in more interactive activities in addition to the roundtable and panel discussion formats. By all accounts, their efforts were quite successful. The 2009 NCYC included a game show on the coffee house stage within the thematic park and a bishop magician performing as part of the comedy club. There were improvements made to the bishop orientation, hospitality, and transportation. From the feedback received to date, the bishops were pleased with their experience at NCYC, as were the attendees connected with the above events.

At the 2009 Annual Membership Meeting in Newport, our primary agenda item was 2009 NCYC with an eye toward preparing for the 2011 NCYC Indianapolis. The task groups that met were: Bishops' Participation, NCYC 2011 Theme, Youth Ambassadors, Exhibitors, Enlace, 2011 NCYC Keynote Speakers. We also formed a group to discuss parent involvement at 2009 NCYC and beyond. The theme for NCYC 2011 was affirmed by the management committee. It will be "R U Ready."

The YEMC would like to thank the work of Stan Cordero who served as management committee chair and Barb Garvin who served on the committee for the past five years. The YEMC welcomed Randy Raus (LifeTeen International), Larry Livingston (Christian Foundation for Children and Aging), and Marilyn Santos (formerly Diocese of Brooklyn/currently Archdiocese of Atlanta). We appreciate the continued support of our fellow diocesan and collaborating members as the YEMC works to improve the experience of NCYC for our young Catholic Church.

Major Gifts Campaign

At the close of 2009, the 25th Anniversary Campaign has earned \$202,351.21 since it began in 2004. The campaign will officially close this year, though there are a few open pledges that will be paid over the next few years.

Annual Grants Program

During the January meeting, the board awarded \$21,000 to fund eight projects supporting youth ministry.

1. Catholic Charities Summer Institute (C²SI), Diocese of Little Rock

Provided funding for a five-day immersion experience for teens designed to teach young people about the church's social teaching through interactive classroom learning, community service, and apostolic Scripture study.

2. Make a Difference, Diocese of San Angelo

Provided funding for a week-long in-service program for diocesan youth to broaden their understanding of justice, peace, and service by examining church documents, studying Scripture, and participating in service opportunities in neighborhoods, working with local service agencies.

3. A Desperate Cry: Preventing Suicide, Santa Maria Addolorata Parish, Chicago

Provided funding for a youth-initiated project focusing on suicide prevention awareness, building healthy self-esteem and positive relationships grounded in Catholic values, and training participants in peer suicide prevention counseling techniques.

4. St. Ann's Summer Camp, St. Ann Parish, Belcourt, North Dakota

Provided funding in support of a Catholic summer camp on the Turtle Mountain Indian Reservation in rural northern North Dakota.

5. Ignite Your Torch Youth Conference, St. Martin De Porres Lay Dominican Community, New Hope, Kentucky

Provided funding for an annual youth conference held in Louisville, Kentucky, attended by over two hundred youth from twelve states, providing high school students with solid catechetical content and realworld faith application, opportunities to attend Mass, Adoration, and confession, and to meet and interact with faithful laity, priest, religious, and other youths from around the world.

6. Mass Media Outreach Project, Diocese of Altoona-Johnstown

Provided funding to produce and broadcast fifteen half-hour television episodes on youth and family catechesis.

7. A Provincial Sharing Retreat, Diocese of Lexington
Provided funding for a three-day working retreat/
professional development weekend for youth ministry
leaders in the seven diocese Kentucky-Tennessee

province.

8. Young Disciples Special Mission on Spirit Lake Reservation, Diocese of Fargo

Provided funding for peer evangelization of young people on an Indian Reservation in rural North Dakota.

In addition to the above, the CYFUSA Board of Directors, at the same meeting, awarded \$3,730 to support two programs focusing on the board's thematic grant program for that year (in conjunction with the Board of Directors of the NFCYM). The theme for 2009 was "Fostering Catholic Identity."

- Diocesan Junior High Day, Diocese of Belleville
 Provided funding for a one-day event for rural junior high school students in order to build and strengthen their identity as Catholics and as future young leaders in their parishes and communities.
- Rise Up: A Spring Break Retreat, Archdiocese of Louisville

Provided funding for an alternative spring break retreat by bringing together a multicultural group of teenagers in the rural mission area of the archdiocese for prayer, study, worship, and service in the context of their identity as Catholics in a predominantly non-Catholic area.

Board Focused Grant Program

During the January meeting, the board also awarded \$5,000 to three projects supporting the board of directors' focused initiative for the year: Involving Parent's in Youth Ministry. They include:

National Association of Catholic Youth Ministry Leaders

The National Association of Catholic Youth Ministry Leaders (NACYML) is currently in the sixth year of operation as a Service Center of the National Federation for Catholic Youth Ministry. The past year has seen growth in membership, increased participation of members in the ongoing work of NACYML, and new challenges for this association.

A look back at highlights from 2009 sheds light on how NACYML works to promote the profession and practice of Catholic youth ministry.

Highlights

- Membership in 2009 remained steady in spite of economic challenges. The NACYML presence at NCYC resulted in the renewal of lapsed membership and current members taking advantage of the opportunity to renew. New memberships were also attained through the NACYML booth at NCYC. Renewal letters to members were mailed in December. As of August, 2009, membership stands at 465.
- Approval of 5 Year Strategic Goals (see attached).
- The Member Services Committee, in collaboration with the Accreditation and Certification Commission is developing Volunteer Competency Standards for youth ministry. The hope is for this document to be available for purchase in an electronic format next fall.
- Diocesan directors who were not already members of NACYML were offered a complimentary membership for one year in order to become acquainted with the NACYML, its members, and work.
- We acknowledge the impact that NACYML members have in the field of ministry through leadership and participation in opportunities and experiences NCYC, NCCYM, the National Symposium on Adolescent Catechesis, local and diocesan leadership, as well as leadership within the organizations and services of collaborating members, and the larger youth ministry community.
- NACYML will participate in the 2011 Lay Ecclesial Ministry Symposium as a sponsoring organization.
- OnCourse, an online continuing education program, offered in collaboration with Ministry Training Source was launched in September of 2008. A series of six webinars, this year's offerings began early in December. Topics and presenters include:
 - » Understanding and Integrating Web 2.0: Tools and the lice Resources in Youth Ministry, MTS: Leigh Sterten and Charlotte McCorquodale.
 - » Volunteers: How to Get and Keep Them, sponsored by the Center for Ministry Development, with Ann Marie Eckert presenting.
 - » Facilitating Parent-Teen Communication: Sister Kieran Sawyer, S.S.N.D.
 - » Self-Esteem: Making Champions of Our Young People: Dr. Robert McCarty.

- » When You Can't Gather Two or More: Non-Gathered Ministry Strategies: Chris Semmel.
- » When Jackie Chan Met Hawkeye Pierce: Conflict Resolution in Ministry: Mike Patin.

NACYML is grateful for the support and generosity of Ministry Training Source in the development and implementation of this program, as well as the contributions of individuals and collaborating members who have generously sponsored and contributed.

The Biennial Membership Meeting is being planned for December 2010 in New Orleans. Current plans include sponsoring a "Living Your Strengths" preconference, facilitated by Dobie Moser and Margaret Vogel of Cleveland, both NACYML members.

National CYO Sports

"I'm only in it for the Kids."

No you're not. In the world of sports, this frequently heard adage is rarely critically examined for what it means, let alone for the lack of self-awareness of the coach or athletic leader who speaks it.

We coach young people in sports because of what we receive from the experience, and we often receive a great deal. We have the privilege of seeing amazing and wonderful things in young people throughout the sports that we coach. Seeing student athletes grow in skills and composure over a season is watching change in action, a reminder that things can and do change in the matter of a few months. Seeing a young person begin to believe in themselves and gain an inner sense of confidence that can drive their outer actions on and off the court is a beautiful thing to watch. Seeing a student athlete discover the importance of being on a team, playing like a team, and believing in the skills of their teammates in the heat of competition is downright fun. Seeing young people connect the dots between their experience in sports and living their faith through acts of kindness, serving together, praying together, and being attentive to teammates, opponents, officials, and fans is inspiring to those who have the eyes to see or the ears to hear. Growing in our Christian faith as disciples of Jesus through athletics is life giving for the coach, the players, and the Christian community.

National CYO Sports (NCYOS) has had a year of growth and development fitting for our fifth year of operation as a recognized partner of the NFCYM. Yet we have significant work lying ahead.

NCYOS has continued to build on what we have been doing since our beginning: Training adult leaders, coaches, and parents to integrate our Catholic mission and values into all aspects of their Catholic sports programs. That has included training sessions in Akron, Cincinnati, Cleveland, Columbus, Detroit, Grand Rapids, Indianapolis, Metuchen, New Orleans, Newark, Mississippi, and Vermont. We have worked with diocesan groups, Catholic high schools, parishes, and parent groups.

NCYOS has continued to work in partnership with the American Sports Education Program (ASEP) to enlist more coaches to take the Catholic Coaching Essentials online coaches training program. This exclusive program places athletics into the context of youth ministry and designates the coaches as youth ministry leaders trying to achieve the goals and vision of *Renewing the Vision*.

In 2009 NCYOS accepted a formal invitation to serve as a member of the United States Olympic Committee (thank you Judy Trancucci, New York Archdiocese, for your years of service). This has led to the sharing of resources and organizational standards that represent the best of the international Olympic movement and the best of CYO sports.

What does it mean to be a National CYO Sports Parish or School? Change of course for 2010 . . .

Our NCYOS Board and Executive Committee has approved a significant change of direction as we move into the future. Our board has continued to grapple with the above question, "What does it mean to be an NCYOS parish or school?" The answers are directing our strategic planning and next steps.

That has led us towards the following answers:

- An NCYOS parish/school places its athletic program at the service or our Catholic mission to help young people to grow as disciples of Jesus.
- An NCYOS parish/school requires coaches to be trained because our young people deserve the best that we can give them. The best coaches are trained to understand why we do sports programs in the Catholic Church and how we can do them effectively to further our mission.
- An NCYOS parish/school actively engages parents as partners to further our Catholic mission and values through sports programs.
- As an organizational member of the United States
 Olympic Committee, NCYOS will actively strive to
 achieve the standards of conduct and ethics of the
 International Olympic movement.
- NCYOS parishes and schools guarantee the right for every child to be on a team and that every child will have the opportunity to play during every athletic competition.

Challenges: We need your help!

As we have clarified what it means to be an NCYOS parish or school, we have shifted our focus to provide the services and materials directly to parishes and schools. We are in the process of setting up our coaches training and parent training materials for coaches to avail themselves of on line coaches training as well as in person coaches training. We need your help in 3 ways:

- 1. Invite NCYOS into your diocese for a meeting with parish or school leaders (decision makers) to learn why it benefits them to become an NCYOS parish or school.
- 2. Identify key Catholic coaches and athletic leaders who would serve as trainers for coaches and parents in your diocese. NCYOS will provide the materials and content for the trainings as well as providing access to our Catholic Coaching Essentials on line coaches training course. There is a small stipend for our NCYOS trainers.
- 3. Be Advocates for making the connection between sports programs in Catholic settings and youth ministry. SPREAD the WORD!
